# A cross-sectorial alliance



- New, EU-level, cross-sectorial alliance of 90 NGOs from different sectors
- Goal: to monitor and support the implementation by the EU and its Member States of the 2030 Agenda for Sustainable Development.
- Launch: October 2016
  - First Vice President of the European Commission, Frans Timmermans, was the keynote speaker.
- Work coordinated along 4 Work Strands:
  - Policy & advocacy coordination
  - Monitoring and review of European SDG implementation
  - Engaging CSOs and citizens
  - Innovating, Experimenting and Learning together


